



Terms and Conditions

Definitions and Acceptance of the Terms and Conditions

1. Tuareg Productions Ltd. ("Tuareg Productions") accepts publication of advertisements on the terms and conditions set out below ("Terms").
2. These Terms apply to Adverts and promotion on www.hangingout.org.uk ("Website") and any associated blogs and social media.
3. By placing an Advert with Tuareg Productions, the Advertiser accepts and agrees to be bound by these Terms in full.
4. An Advert placed on the Website shall consist of:
 - (i) a permanent feature article written by our staff, to the Advertisers approval, or a feature article written by the Advertiser, to Tuareg Productions approval, to appear on the appropriate Website Blog;
 - (ii) an 80x80 pixel image of the Advertisers choice, subject to the approval of Tuareg Productions, on the Website homepage (www.hangingout.org.uk/Home_preload2.htm), with the option of a "Rollover image", linking to a website of the Advertisers choosing subject to the approval of Tuareg Productions, or

8. The Advertiser guarantees to Tuareg Productions that:
 - (i) any information supplied in connection with the Advertisement is accurate, complete, true and not misleading;
 - (ii) it has obtained the consent of any living person whose name or image (in whole or in part) is contained in any Advertisement;
 - (iii) all Advertisements submitted for publication online will be free of any viruses and no Advertisement will cause an adverse effect on the operation of the Website;
 - (iv) the Advertisements are legal, decent, honest and truthful, are not contrary to the provisions of any applicable law, regulation or code of practice.
